3. The Company will send goods at the earliest opportunity in one lot of part according to their convenience.
4. The goods will be delivered at the destination in the company's godown only unless settled otherwise against all charges.
5. If delivery is not taken within ten days of arrival of goods at destination, the company will not be responsible or damage of goods.
6. The carriers under no circumstances shall be liable for compensation where goods are booked at owners risk.
7. If delivery is not taken within six months the company has authority to of the goods.
8. The Company take absolutely no responsibility due to accident on route & consequence thereof.
9. In case a Beopary accompanies the goods he will be responsible for loss of goods on route.
10. If delivery is not taken within three days of arrival of goods the company will store the goods at owner's risk and account will charge demurrage 3 paisa per day per K.G.
